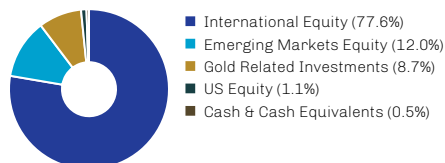

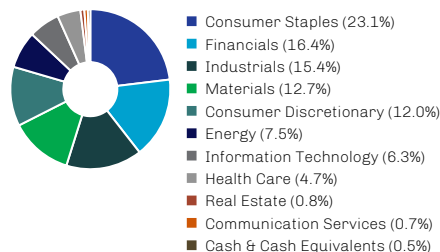

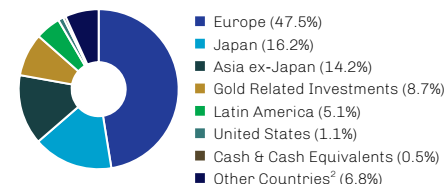
Allocation by Asset Class
