

## As of August 31, 2025

The First Eagle Funds, First Eagle Tactical Municipal Opportunities Fund and First Eagle Credit Opportunities Fund are required by federal tax law to distribute prior to December 31 virtually all net capital gains that were realized prior to October 31 and all ordinary income earned for the calendar year. Funds which do not meet this distribution requirement would be subject to an excise tax. To assist our financial advisors, we have prepared the following estimates of ordinary income and capital gain distributions for the First Eagle Tactical Municipal Opportunities Fund and First Eagle Credit Opportunities Fund.

These estimates may change due to a change in the level of shares outstanding, tax adjustments and actual income versus estimated amounts.
